He previously served as a staff attorney with the Fire Prevention Division of the Department of Labor and Industry and with the Department of Public Safety. He obtained his law degree from the Vermont Law School, and a B.A. from the University of New Hampshire.





## **Dr. Margaret Morrissey-Basler**

Dr. Margaret Morrissev-Basler is an Assistant Professor of Health Sciences at Providence College and the Senior Advisor of Occupational Heat Safety Advisor at the Korey Stringer Institute. She has over 34 peer-reviewed publications on heat stress, worker health, and hydration and led a 51-expert roundtable on occupational heat safety, resulting in a heat safety consensus document. She also serves as the Chair of the Thermal Stress Working Group at AIHA and a subcommittee member of the recently published ANSI/ASSP A10.50 heat stress construction voluntary standard. She has been invited to speak about heat safety at many safety events and conferences, such as NSC, VPPPA, AIHce, AIHConnect, ACGIH, and NIHHIS. She has consulted with numerous organizations, such as UPS and Delta Airlines, to improve their heat stress management plans. She dedicated her career to providing evidencebased quidelines to protect underserved working populations from heat stress through research, education, and advocacy initiatives.



#### **Scott Whittier**

Scott Whittier is the Warning Coordination
Meteorologist (since 2008) at NOAA/NWS Burlington, VT
Forecast Office and has been at NWS Burlington since
1993. Scott was awarded the Northeast States
Emergency Consortium's Emergency Manager of the
Year for VERMONT in 2013 for his efforts with
Tropical Storm IRENE (2011) and Vermont's Catastrophic
Full Scale Exercise (2010). Scott has worked closely
with the VT Department of Health and NWS Public
Service Program to elevate the dangers of heat through
new heat tools, collaborated on heat safety messaging
and developed a dedicated local heat page weather.gov/btv/heat. Scott graduated with a Bachelor
of Science degree in Meteorology from Lyndon State
College in VT.
